**From the east:** Hwy 23 west to Hwy KK, left (west) on KK (which becomes Hwy K) to Hwy A, right (north) on A to South Street, left (west) to Evensong Way, Left (south) on Evensong to home

**From the west:** Hwy 23 east to S. Lawson Dr, right (east) onto S. Lawson Dr, S. Lawson Drive turns into South St, Stay right (east) on South Street to Evensong Way, right (south) on Evensong Way to home

**From the north:** Hwy 49 south to Hwy A, stay straight (south) on Hwy A to Commercial Ave., Right (south) on Commercial Ave. to South Street, right (west) onto South Street to Evensong Way, Left (south) on Evensong Way to home

**From the south:** Hwy 49/44 to Hwy A, North on Hwy A to South Street, left (west) to Evensong Way, Left (south) on Evensong to home

(Note: Evensong Way is located along the West side of Tuscumbia Golf Course)

**From the east:** Hwy 23 west to Hwy KK, left (west) on KK (which becomes Hwy K) to Hwy A, right (north) on A to South Street, left (west) to Evensong Way, Left (south) on Evensong to Fiddlehead Court

**From the west:** Hwy 23 east to S. Lawson Dr, right (east) onto S. Lawson Dr, S. Lawson Drive turns into South St, Stay right (east) on South Street to Evensong Way, right (south) on Evensong Way to Fiddlehead Court

**From the north:** Hwy 49 south to Hwy A, stay straight (south) on Hwy A to Commercial Ave., Right (south) on Commercial Ave. to South Street, right (west) onto South Street to Evensong Way, Left (south) on Evensong Way to Fiddlehead Court

**From the south:** Hwy 49/44 to Hwy A, North on Hwy A to South Street, left (west) to Evensong Way, Left (south) on Evensong to Fiddlehead Court
